## **SUBJECT: - LAUNCHING THE NOC TRANSFER SYSTEM FOR ATHLETES**

Dear All Concerned,

WAKO India has decided to launch the NOC System in keeping view the requests received from the Athletes who want to change their State/UT of Participation due to Joining a Job/Transfer of his/her Parents/Place of work/Studying/Residence, etc., but they are unable to change their State/UT due to WAKO India WAKO global ID (Rsports) system. In other words, one athlete has already participated from one state and due to some reasons, he has shifted to other state and wants to represent the new state where he has shifted. To enable such athlete who wants to change the state of participation, the new NOC system of WAKO India will allow the athlete to move a new State from where he/she wants to play.

### **THERE ARE 3 STEPS TO APPLY FOR NOC:-**

#### **1) UNIT FROM WHICH KICKBOXER INTENDS TO REPRESENT**

In this process, firstly Athlete has to submit the NOC Form to the new State from which he/she wants to represent now onward. The new State will give the NOC after checking (copies attached) the authentication of his/her documents.

#### **2) UNIT IN WHICH KICKBOXER IS CURRENTLY REGISTERED**

After receiving the NOC form from new unit, athlete will go to the current state and submit the NOC Form to the President or Secretary of the respective State/UT and after checking to ensure that all necessary permissions and clearances, NOC will be given by the current unit in the same form.

#### **3) FINAL-APPROVAL FROM WIKF OFFICE**

After completion of two steps, Athlete will go to the WIKF Administrative office to submit the NOC Form and other related documents for approval.

After completion of all above proceedings, the athlete is officially allowed to participate in the National Events. This will help in maintaining transparency and order in the conduct of the championships. After transferring from one State to another, athlete can't change his/her state further minimum for one year.

**TERMS AND CONDITIONS :-**

- If the athlete does not obtain NOC form from where he/she wants to represent for the current unit within one month or he/she does not submit NOC form to WIKF within one month from the date of obtaining the NOC, he/she will continue to represent from the old unit only.

**IMPORTANT NOTE:**

- Application for Transfer should be reached to WIKF office within 7 working days.
- Transfer fee is Rs. 2000/- by D.D/Cheque/online etc. in favour of WIKF only.
- Attach photocopies of documents (Attested by Secretary of State/UT) confirming reasons for transfer such as Joining a Job/Transfer of his/her Parents/Place of work/Studying/Residence, etc.
- No photocopy of NOC form will be entertained through any online mode like Whatsapp/email etc.
- Only original WIKF NOC form will be valid or authenticate for further approval.
- After approval from WIKF Office, the office will intimate to the former state, current state and the concerned athlete through E-mail only.
- Only concerned Athlete will be responsible to complete this process in stipulated time period.
