Sub: Compliance of WADA Code & NADA Rules by Sports Federations.

Sir / Madam,

The Government of India grants recognition to National Sports Federations (NSFs) for promotion and development of the sports discipline in the country for which they have been recognized by the concerned International Federation. The Government recognition makes the NSFs eligible for financial and other support from the Government. The financial proposals and plans for development of the concerned sports disciplines are reviewed annually in the Annual Calendar of Training & Competitions (ACTC) meetings chaired by Secretary (Sports).

- 2. Reference is invited to the National Anti-Doping Rules 2021 (NADR 2021), which are in compliance to the World Anti-Doping Code 2021 (Code), being implemented by the National Anti-Doping Agency (NADA). The purpose of the Code is to protect the Athletes' fundamental right to participate in doping-free sports. The implementation of Code requires cooperation from all participating stakeholders for effective anti-doping programs at the national and international level. Under the NADR 2021, NSFs are required to accept and abide by the spirit and terms of India's National Anti-Doping Program and the Anti-Doping Rules as a condition of receiving financial and/or other assistance from the Government of India and/or the National Olympic Committee of India. NSFs are also required to discharge certain roles and responsibilities, which have been indicated NADR 2021.
- 3. NADA undertakes on regular basis programmes aiming to create awareness about the anti-doping rules, dope control process, sanctions and responsibilities of athletes and athletes support personnel. It is not out of place to mention that the WADA Code under Article20.3.13 and Article 18.9 of the NADR 2021 provide that all National Federations shall conduct anti-doping Education in coordination with NADA.
- 4. Considering all aspects towards protection of Athletes' fundamental right to participate in doping-free sport, fairness and equality, etc. it has been decided that NSFs shall henceforth include in their ACTC proposals the details about anti-doping educational plans and anti-doping programmes. For bringing out effective anti-doping pragrammes in order to uphold

the highest values of fair play and honesty which are the very essence and ethos of sports, NSFs are advised to coordinate with NADA and to take following actions:

- share the ACTC & domestic calendar of events with NADA office on regular basis to prepare yearly test distribution plan.
- facilitate the Registered Testing Pool (RTP) athletes for uploading of whereabouts information of RTP Athletes.
- intimate NADA in writing about the retired athletes.
- provide ranking of National level Athletes to NADA.
- 5. All the recognised NSFs are also advised to provide a hyperlink of website of NADA on their websites for guidance and benefit of athletes.
- 6. All NSFs are requested to designate a Co-ordinator for anti-doping activities, who shall regularly liase with NADA. Details of this nodal point may be informed to DG, NADA by 15th July 2021.
- 7. During all in-competition sample collections, the organizers shall provide all required facilities for the smooth conduct of the dope testing in line with WADA Code 2021 related WADA Standards and NADR 2021. NADA shall be contacted prior to organization/holding of in-competition events, at least 2 weeks in advance, and their requirements ascertained.
